**ENFORCEMENT NOTICE
Unauthorised Development**

ISSUED BY THE COUNCIL OF THE BOROUGH OF BROXBOURNE ("the Council")

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to it that there has been a breach of planning control, under Section 171A(1)(a) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THIS NOTICE RELATES**

Land at 22 Leaforis Road, Cheshunt, Waltham Cross, Herts EN7 6NB ("the Premises") shown edged red on the attached plan.

3. **THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL**

Without planning permission, the erection of a rear roof terrace.

4. **REASONS FOR ISSUING THIS NOTICE**

It appears to the Council that the above breach of planning control has occurred within the last four years.

Due to its undue prominence, caused by its positioning on the Premises and the materials used in its construction, the roof terrace alteration represents poor quality design that fails to relate to the established pattern of development, resulting in an incompatible addition that is harmful to the visual interest and therefore the character and appearance of the host property and the wider area. The unauthorised roof terrace affords views into the neighbouring households and therefore negatively impacts on the privacy of neighbouring occupiers.

The unauthorised development is therefore contrary to Policies H6, H8, HD13 & HD14 of the Adopted Broxbourne Local Plan Second Review 2001 – 2011 and polices contained in the emerging Local Plan and the National Planning Policy Framework.

5. **WHAT YOU ARE REQUIRED TO DO**

- i. Remove the wooden panelling and the supports that form the rear roof terrace (as shown in the photograph at Appendix 'A' of this notice) from the Land, including all fixtures, fittings and waste materials therefrom.


6. **TIME FOR COMPLIANCE**

One (1) month after this notice takes effect.

7. **WHEN THIS NOTICE TAKES EFFECT**

This Notice takes effect the **30th January 2018** unless an appeal is made against it beforehand.

The Planning Inspectorate has introduced an online appeals service which you can use to make your appeal online. The Inspectorate will publish details of your appeal on the Internet (on the Appeals area of the Planning Portal). This may include a copy of the original planning application form and relevant supporting documents supplied to the local authority by you or your agent, together with the completed appeal form and information you submit to the Planning Inspectorate. Please ensure that you only provide information, including personal information belonging to you that you are happy will be made available to others in this way. If you supply personal information belonging to a third party please ensure you have their permission to do so. More detailed information about data protection and privacy matters is available on the Planning Portal.

Please note that a separate appeal form must be completed for each individual person or individual organisation. Each appeal may attract a fee as set out below.

IF YOU APPEAL

If you lodge an appeal then you must submit to The Planning Inspectorate a statement in writing specifying the grounds on which you are appealing against the enforcement notice, and stating briefly the facts that you propose to rely on, in support of each of these grounds, either

- When giving notice of appeal OR
- Within 14 days from the date that The Planning Inspectorate sends you a notice that requires you to send a statement

If you wish to have your appeal also considered as a deemed application for planning permission, or you intend to make an appeal under Ground (a), you may be required to pay a fee.

A fee may be payable for the deemed application for planning permission for the development alleged to be in breach of planning control in the enforcement notice. This is pursuant to regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 (7).

The fee for this case is **£344.00**. This amount is payable to the Council.

- Once your appeal has been submitted to the Planning Inspectorate, payment can be made by phone with the Planning Technical Support Team on 01992 785555 or planning@broxbourne.gov.uk. Please quote the Enforcement Case Reference Number (see the top of this Notice) and the Appeal Reference Number (see the top of your electronically completed appeal form).
- The Development Management Service no longer take payment by cheque. Payment may be made by Credit Card or by BACS.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice before the effective date you may be held responsible. Therefore you must ensure that the required steps detailed under the heading "What you are required to do", of Schedule 4 of this notice are complied with, within the period specified in the notice.

Failure to comply with an enforcement notice, that has taken effect, can result in prosecution and/or direct action by the Council.

You MUST make sure that we receive your appeal before the effective date on the enforcement notice.

In exceptional circumstances you may give notice of appeal by fax or letter. You should include:-

- the name of the local planning authority;
- the site address;
- your address; and
- the effective date of the enforcement notice.

We MUST receive this before the effective date on the enforcement notice. This should **immediately** be followed by your completed appeal forms.
